#### **COURSE DESCRIPTION:**

This course has been designed to train Police Officers and Firefighter/Paramedics in the specialized skills sets necessary to perform the Active Threat Rescue Task Force mission.

**Rescue Task Force Operational Concept:** Police Officers and Firefighter/Paramedics operating together in the warm zone during and Active Threat Situation rapidly performing critical lifesaving medical procedures and triage under the force protection of law enforcement. Accessing victims early will increase the probability of saving lives of those who may otherwise die from their injuries.

**COURSE GOALS:** The goals of this course are as follows:

- Ensure students have an excellent understanding of Rescue Task Force tactics and strategy.
- Ensure students can perform Rescue Task Force Tactics
- To provide students with an inventory of appropriate equipment to be used when performing the Rescue Task Force mission.
- To allow students the opportunity to participate and practice the Rescue Task Force skill sets in a realistic, scenario-based training environment.

### **RESCUE TASK FORCE EQUIPMENT LIST:**

- Clothes suitable for training in any weather conditions
- Eye and Protection
- Rifle with sling and minimum 3 mags (Optional)
- Pistol with holster and 3 mags
- Duty belt
- 50 rounds minimum of rifle ammunition (Optional)
- 100 rounds minimum of pistol ammunition

### **MAXIMUM 12 PEOPLE**

#### **Non-Member Tuition:**

**\$200.00.** Non-member tuition shall apply to State/Federal agencies and Local Law Enforcement agencies which are not members of MTU #9. Tuition will be invoiced to departments upon course completion. If a pre-registered student from a Non-Member agency fails to attend training, and the agency fails to provide advance notice within 7 days of the start date of that class, the agency will be invoiced the entire amount of the student's tuition. #### **No Shows/Cancellation Policy**
