This training will focus on US Supreme Court decisions, Federal Appeals cases, Force Continuums, documentation of an officer's use of force, Garrity issues, the Illinois Peace Officers Disciplinary Act, Defense/Plaintiff's Lawyers attacks on Police Use-of-Force and Use of Force Myths.
