INSTRUCTOR

Corporal Mitchell Barton started his career in Law Enforcement in 2016 with the Canton Police Department in Canton, Missouri. Currently Barton works for the Pittsfield Police Department. He has been a certified Taser Instructor through Axon International since 2018. Barton has served as the School Resource Officer for the Pikeland School District and as a Field Training Officer with Pittsfield. Officer Barton also instructs and competes in Brazilian Jiu Jitsu and Judo through Midwest Jiu Jitsu Academy.

COURSE DESCRIPTION:

This course will serve as a basic user certification course and/or a re-certification course. Course materials provided by Axon International will obtain information related to Conducted Energy Weapons (CEWs). The course content will include but not limited to basic operations of CEWs, nomenclature of CEWs in use, proper handling and maintenance, legal updates, and case law.

Note: ** Students will be provided an Online Link to complete the classroom portion of the training provided by Axon International. Students MUST complete the ONLINE before attending the afternoon session and participation in practical exercises to include proper loading and unloading drills, proper drive stun applications, deployment risk, drawing drills, and proper evidence packaging procedures.

Following an evaluation, students will be provided scenario based live fire exercises to include but not limited to; malfunction drills, reload while under stress, disconnect drills, and drive stun follow up drills.

STUDENTS MUST BRING THE FOLLOWING:

Students are expected to provide CEW, safety glasses, duty belt and holster for CEW, and a minimum of two live cartridges. Duty weapons and or knives are not allowed during practical section of training.

No Shows/Cancellation Policy
