The Prison Rape Elimination Act (PREA) of 2003 is a federal law established to address the elimination and prevention of sexual assault and rape in the correctional systems. PREA applies to all federal and local prison, jails, lock-up's, private facilities, and community settings such as residential facilities. PREA seeks to ensure that jails and other correctional facilities protect inmates from all forms of sexual assault.

### Non-Member Tuition:

**\$0.00**. Non-member tuition shall apply to State/Federal agencies and Local Law Enforcement agencies which are not members of MTU #9. Tuition will be invoiced to departments upon course completion. If a pre-registered student from a Non-Member agency fails to attend training, and the agency fails to provide advance notice within 7 days of the start date of that class, the agency will be invoiced the entire amount of the student's tuition. <u>See Tuition Policy Here</u>

### No Shows/Cancellation Policy

West Central IL Criminal Justice Council-MTU #9 has instituted a No Show/Cancellation fee of \$50.00 to be invoiced to member/nonmember agencies who do not provide sufficient notice of cancellations seven (7) days before start of class.
