COURSE DESCRIPTION:

This training will cover a myriad of topics relating to sovereign citizens and police responses. Part 1 will cover topics to raise sovereign citizen awareness. Initially, sovereign citizen ideologies and why they matter to law enforcement will be covered. Then, a historical context of the sovereign citizen movement, the structure of the movement, its leaders-ideologues-gurus, their modes of radicalization and recruitment and their implications will be shared. Next, the issue of how does a person "benefit" by being a sovereign citizen will be covered. Then, sovereign citizen movement membership and affiliation will be highlighted. Subsequently, varied tactics and activities of sovereign citizen will be discussed. A separate section focusing on traffic stops involving sovereign citizens will be noted. In turn, sovereign citizen threats against law enforcement and government officials will be elaborated.

The second part of the training will address, law enforcement and other responses to sovereign citizen threats. Among the topics covered are:
