### **\*PRE-REQUISITE:**

- 1. Must have completed 40-Hour Basic Firearms Instructor Course**
- 2. Must currently be serving as your agency's or the MTU Firearms Instructor**

### **COURSE OBJECTIVE:**

This 4-hour remediation class is designed to provide basic firearm instructors the opportunity to refresh their instructor skills through live fire range sessions and basic firearms skills teach backs.

  - Live fire pistol drills
  - Pistol skills teach backs
  - Pistol Qualification
- Rifle**
  - Live fire rifle drills

  - Rifle Qualification
