### COURSE REVIEW:

This four-day, 32-hour training program has been redesigned for 2025. This course will provide law enforcement and corrections officers with the knowledge and skills to train probationary officers in a one-to-one setting. Diverse instructional methods will be employed to provide a student-centered learning environment.

Attendees will receive a new comprehensive manual to assist with their training post-course. They will do a deep dive into the Standardized Evaluation Guidelines. The attendees will complete several in-class DOR's to help them with performance evaluation, remediation of errors, providing proper feedback, and documenting daily training activities using the Standardized Evaluation Guidelines. Attendees will have the opportunity to teach and coach each other during the class. They will complete a performance improvement plan to provide documentation of training deficiencies and provide a written plan for improvement. The attendees will look at tactics for teaching the Gen Z trainee to assist with better decision-making and critical thinking.

### COURSE GOALS:

- Provide the Field Training Officer with the knowledge needed to work with, guide, coach, teach, evaluate, and mentor a newly hired police officer.
- Give the new FTO the tools needed to help the trainee to transfer and apply what they were taught in academy, along with other life experiences, to situations the officer will encounter on a daily basis.
- Familiarize the trainee with the department, the department's vision, goals and objectives and the environment the trainee will be working in.
- Provide the trainee with daily guidance, direction, monitoring, while being faithful, fair, and objective.

### Non-Member Tuition:

**\$200.00.** Non-member tuition shall apply to State/Federal agencies and Local Law Enforcement agencies which are not members of MTU #9. Tuition will be invoiced to departments upon course completion. If a pre-registered student from a Non-Member agency fails to attend training, and the agency fails to provide advance notice within 7 days of the start date of that class, the agency will be invoiced the entire amount of the student's tuition. If an agency is unable to provide advance notice of its intent to cancel course registration because of circumstances beyond its control, the Director will have the discretion to waive this payment.
