## **PURPOSE OF COURSE:**

This course has been designed for the purpose of addressing the issue of Autism Spectrum Disorders (ASD) as it specifically relates to people who are on the autism spectrum when they interact with law enforcement. It is designed to provide information and understanding to officers as they serve people with ASD and who display signs and symptoms of this disorder. The training will focus on helping officers identify individuals with autism spectrum disorders, understand their communication styles, and develop appropriate response techniques.

## **COURSE DESCRIPTION.**

Citizens who display signs and symptoms of ASD present a unique challenge to the criminal justice system because of their presenting issues such as limited social communication, behavioral difficulties, and environmental sensory sensitivities. This course will provide officers with an understanding of ASD. Including signs and symptoms, the wide range of ASD challenges while interacting with police. We will review appropriate responses to people with ASD, measures for reducing misunderstandings, symptom reduction techniques, and de-escalation approaches of citizens with ASD and recommendations for an increase in officer sensitivity and knowledge. The goal is to improve between law enforcement and people with autism, leading to safer and more effective outcomes.
