COURSE DESCRIPTION:

ILETSB Executive Institute designed to train officers in the fundamentals and tactical skill sets required during high-risk patrol operations, this course provides the knowledge, specialized tactical skill sets, and strategic understanding to be able to manage and perform three critical high-risk patrol functions: building searches, felony traffic stops, and arrest team tactics.

Bring all necessary equipment for responding to high-risk situations.
