### **COURSE DESCRIPTION:**

ILETSB Executive Institute Rapid Deployment/immediate action is the swift and immediate deployment of law enforcement resources to a life-threatening active threat situation. These situations require immediate action and the rapid deployment of law enforcement. Failure to act has catastrophic consequences resulting in death and/or great bodily harm to innocent people. These incidents may also necessitate the immediate and rapid deployment of personnel to contain and prevent the escape of an armed and dangerous offender or rescue a downed officer and/or civilian.

### **STUDENTS NEED TO BRING THE FOLLOWING:**

Bring all necessary equipment for responding to high-risk situations.

**Non-Member Tuition:** **\$0.00\*\*** Non-member tuition shall apply to State/Federal agencies and Local Law Enforcement agencies which are not members of MTU #9. Tuition will be invoiced to departments upon course completion. **No Shows/Cancellation Policy:** West Central IL Criminal Justice Council-MTU #9 has instituted a No Show/Cancellation fee of \$50.00 to be invoiced to member/non-member agencies who do not provide sufficient notice of cancellations seven (7) days before start of class. This Fee will be invoiced within a week of an officer's absence from a training course in which he/she was registered. If an agency is unable to provide advance notice of its intent to cancel course registration because of circumstances beyond its control, the Director will have the discretion to waive this payment.
