Meets IL Mandates: Emergency Medical Response training and certification (.50 hr./50 hr. scenario-based training), High-Risk Traffic Stops (6 hrs./6 hrs. scenario-based training), Officer Safety Techniques (5.5 hrs./5.5 hrs. scenario-based training)

COURSE PREREQUISITES: Must be a state certified police officer.

PURPOSE OF COURSE:

To provide officers the opportunity to practice and perform the necessary skills to prevail in real world encounters in a safe and constructive training.

COURSE DESCRIPTION:

This 2-Day course is designed to teach officers the critical skill sets needed to not only survive, but to prevail in high-risk incidents. This will be accomplished by a very intense and strenuous training schedule. In order to develop the skills and tactics needed in a short period of time, students will need to be ready to train at a very high level of intensity.

COURSE GOALS:

The goals of this course are as follows:

- To provide a detailed explanation of conventional police tactics for managing barricade/hostage situations.
- To review a study of the dramatic increase in the number of workplace and school shooting incidents.
- To provide students with an understanding of why Rapid Deployment/Immediate Action techniques were developed and the need for them to be integrated into the tactics available for law enforcement.
- To assist participants in developing an awareness of the critical elements that constitute an active shooter and when the use of Rapid Deployment/Immediate Action tactics are appropriate and necessary.
- To provide students with an understanding of what should be accomplished by initial responding officers and what the components and responsibilities of the “contact” and/or “rescue” team are.
- To identify and discuss use-of-force and safety priority issues related to Rapid Deployment/Immediate Action incidents, including immediate defense of life, law, police, & procedure, and established safety priorities.

- To provide students with an inventory of appropriate equipment to be used when conducting these types of operations, including issues related to weapon and ammunition selection and uniform/identification requirements.
- To provide students with a foundational understanding of defensive tactics and appropriate use of force options while making arrests.
- To provide students the opportunity to participate in counter-ambush scenarios while conducting high risk traffic stops.
- To provide students the opportunity to conduct live fire exercises in a controlled manner so they can understand the differences between cover, concealment, and ballistic deviation in and around vehicles.

COURSE PREREQUISITES: Must be a state certified police officer.

Students need to bring the following:

- Duty belt
- Comfortable clothes for Defensive Tactics portion
- Mouth guard

Non-Member Tuition: **\$0.00**** non-member tuition shall apply to State/Federal agencies and Local Law Enforcement agencies which are not members of MTU #9. Tuition will be invoiced to departments upon course completion.
