Meets IL Mandates: Constitutional Use of LE Authority (1 hr.), Emergency medical response training, and certification (1 hr.), Law concerning stops, searches, and the use of force (2 hrs./2 hrs. scenario-based training), Officer safety techniques, including cover, concealment, and time (12 hrs./10 hrs. scenario-based training), Active Threat Response (16 hrs./12 hrs. scenario-based training)

MACTAC is the swift and immediate deployment of law enforcement resources to an Active Threat/Terrorist attack, which may include multiple, simultaneous attack situations. These situations require immediate action and the rapid deployment of patrol officers. Failure to act could have catastrophic consequences resulting in death and/or great bodily harm to innocent people. These incidents may also necessitate the immediate and rapid deployment of patrol personnel to contain and prevent the escape of an armed and dangerous offender or rescue a downed officer and/or civilian.

Please bring duty belt, vest, and rifle if you have one.
